









EC KT Landscape











Our Contract & Collaborative (CCR) Group






2012: CONCLUSION:

- To provide assistance in the transfer of technologies for all Slovenian researchers


2014: PROGRAM Ministry of economy financing: 550.000 EUR/16 months.



- The best newcomer state institution in terms of attained projects, success rate, financing per researcher.



Research and Assistance activities present a preparative activity for TT – an enabler ... Making TT more efficient and embedded into the system.







Take home message on successful NEW Tech Transfer Office creation

Market analysis approach.

To activate customers, subsidize financing with clear goals and follow through:

- EU projects national financing

Once **activated**, assure financing to customers - make available i.e. 5% of research project financing only for KT activities at the discretion of the researcher.
